#### Conditions of Transfer and Documents Required:

1) Transfer of telephone from Individual to blood relation or third party:

A customer during life time will be permitted to transfer his telephone to any person or firm. In case the customer wants refund of his deposit following will be applicable.

In case of OYT Telephone: The balance amount of the transferor shall be refunded to him after deduction of all outstanding dues up to the date of transfer. The transferee will make payment of advance annual rental (Security Deposit) and bimonthly rental as applicable for Non-OYT General Category.

In case of Non-OYT category telephone: The security deposit, if any, will be refunded to the transferor after the deduction of all outstanding dues. The transferee will pay advance annual rental (Security Deposit) and bimouthly rental, as applicable for telephone under Non-OYT-General category.

## 11) Transfer of telephone in the case of Firm/Company:

# a) On the change of name and or constitution.

Transfer of telephone may be permitted in the event of change of name and for constitution of a company due to statutory obligations or other-wise.

In all cases subscriber can apply on company's letter head giving details for change of name, due to change in constitution, dissolution of partnership firm sale of business etc. and enclosing the relevant documents indicating the change in name / constitution etc. of the company.

## b) Transfer of a telephone from employer to employee.

Subscriber has to apply in Third Party Transfer application form.

Transferee has to produce declaration letter from the employer (company) on company letter head stating that "that balance amount of OYT/Non-OYT deposit, paid by the company for the telephone connection may be transferred in the name of transferee (employee) or will not have any claim of any kind over it, and any outstanding dues will be paid by the company."
